- Eiffel: Revision is still in progress.

Steve Michell (Canada) pointed out that there has been no report in several years and that status as a PAS submitter has expired; perhaps we should drop them as a liaison. Simonsen volunteered to be an additional liaison representative. The chair will investigate.

ISO/IEC 10646:2011 (2<sup>nd</sup> edition) was published. They are balloting a third edition while preparing an amendment for the third edition. A new sorting standard, 14651, is near publication.

Ogawa has retired; that's why he is not listed as a liaison to SC22. The chair suggests that our resolution naming a liaison to SC7 should drop Ogawa also. Keaton suggests that Seacord might want to participate in the embedded system study group.

#### 7.3.4 Liaison Officer to JTC 1/SWG-Directives (S. Michell)

The committee met a few weeks ago. The parent groups are trying to reduce the period of time required by DIS ballots. (Since JTC1 does not translate documents, they might be permitted to use a 3-month period.) The parents would like to reduce CD ballots to two months. (The default period in the balloting system is now two months.)

Standing documents will have to be enumerated so that it can be ensured that they do not contradict the directives. SC22 has one standing document. An updated version of the merged directives should be published within the next few weeks. Some material has been moved from the JTC1 Supplement to standing documents.

Discussion of permitting Excel spreadsheets for commenting is ongoing. On the JTC 1 website, there is a "Forms" folder containing things like NWIP forms. (JTC 1, ISO and IEC each have a different form.)

There has been some clarification of how to perform ballot resolution for fast-track and PAS. The BRM can make small changes and then conduct an FDIS ballot.

Steve believes that the idea of creating a new class of documents by SWG-Accessibility is a ploy to get rid of freely available technical reports and standards.

We may get a revised set of Directives in January.

We have one standing document; it is available on the website and lists rules we have imposed upon ourselves.

#### 12.3 Status Report on RUBY

The report was made by Yoshida-san. JIS X30-17 was published this year in Japan and forwarded for fast-track as ISO/IEC 30170. Voting closed 6 September; it received a 100% approval. Only Japan made comments. Japan would like to skip having a Ballot Resolution Meeting. Sally said that Japan can circulate a proposed disposition and ask if a BRM is needed. Because the proposed change is substantive, an FDIS ballot will be required.

JIS will keep a working group in place in IPA and will accept responsibility for maintaining the standard. He invited other nations to provide members of the IPA working group.

(Yoshida-san made a point of thanking me for Jim Johnson's presentation at the Ruby conference.)

### 12.4 ISO Teleconference and Web Conferencing Training 12.5 Endorsement of Jaeschke for a Second Three-Year term as Chairman

This was agreed without objection.

## 13. APPROVAL OF RESOLUTIONS AND STATEMENT OF RESULTS

Draft resolutions were distributed for review. We go through the resolutions and make corrections. Important items are noted below:

- Resolution 11-02 authorizes the Secretariat to circulate NP and WD for code signing.
- WG11 (language-independent interfaces) was disbanded.
- WG16 (LISP) was disbanded.
- POSIX Advisory Group was disbanded, but we retained some liaisons and organizational representatives to appropriate groups.
- Requested free availability of new ECMAScript standard.
- Appointed me as liaison to SC 7 and to SC 27.
- Benito was reappointed as convener of WG14 and WG23.
- Rex Jaeschke was endorsed for a second three-year term as chair of SC22.
- For several standards (including TR 24731-1), we recommended reconfirmation, but for JEFF, Z, FORTH, we recommended stabilization.
- It was agreed that web conferencing should be provided for future SC22 plenary meetings. It was agreed to schedule a "training" meeting of SC 22, using electronic methods, in May or June of 2012.
- It was noted that appropriate forms, including NP forms, are located in the forms folder of the JTC1 eCommittee website.
- The 2012 plenary meeting of SC22 is scheduled for 10-11 September 2012 in Geneva.
